What are your data protection rights?

Cookies are text files placed on your computer to collect standard Internet log information and visitor behaviour information. When you visit our websites, we may collect information from you automatically through cookies or similar technology

How do we use cookies?

What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- **Functionality** – Teen-Behaviour.Com Ltd uses these cookies so that we recognize you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.

- Advertising – Teen-Behaviour.Com Ltd uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. Teen-Behaviour.Com Ltd sometimes shares some limited aspects of this data with third parties for advertising purposes.
